ELIGIBILITY: This pre-seeded meet is open to all swimmers, 9 years old and younger, registered with USA Swimming and will be conducted according to current USA Swimming Code of Regulations. No proof of time is required, as there are no qualifying times. The age of the swimmer on May 19, 2002 will determine the age group the swimmer can enter. USS registration numbers are required to be placed on the official entry blank for all swimmers. Please understand that the Meet Director has the right to limit the heats, entries, or events to conform with Middle Atlantic rules. Notification will be provided to swimmers and teams concerning limitation/elimination of any heats/events. Meet fees will be refunded to teams/swimmers who do not participate in any event due to limitations.

ENTRIES: Swimmers may enter a maximum of 5 (five) individual events. Penalties will be imposed upon any swimmer when any coach, parent, swimmer enters any time other than the swimmer's best time for any event and could result in the swimmer's suspension from competition for a minimum of three months, but not more than one year. Further violation by a coach, parent, or swimmer could result in that person being forbidden to participate in or attending U.S. Swimming functions.

FACILITY: **Location - McKean High School, 301 McKennans Church Road, Wilmington, DE** 6 lane, 25 yard pool with electronic timing, judging system, and scoreboard. Depth of the pool at the starting end is 12'. The height of the starting blocks is 29". Snack bar will be available.

DIRECTIONS: From Philadelphia and New Jersey - Take I-95 South (follow signs for Baltimore) to Churchman's Rd (Route 7 north) exit. Bear right at top of ramp. Bear right, after the first light, onto Route 7 North. Proceed on Route 7 North (Stay to your left at Rte 4 interchange), cross over Kirkwood Highway (Rte 2), until you bear right at Mealy Funeral home onto McKennan's Church Road. Continue straight until you come to high school entrance on left...approx 2 miles.

From Maryland - Take I-95 North to exit for Route 7 North and then follow above directions.

AWARDS: Large rosette ribbons for 1st through 3rd.
Standard ribbons for 4th through 12th place.

PROGRAM &

ADMISSION: \$3.00 (No charge for children under 8) OFFICIALS ADMITTED FREE.

ENTRY INFORMATION: All entries must be filled out on the official entry blank OR entries must be sent on a 3 ½ disk (If you have the Hy-Tek computer programs Team Manager and COMMLINK, submit the following printouts along with the diskette: 1 printout from COMMLINK of entries, 1 printout from COMMLINK of swimmers, 1 printout from Team Manager of the meet entries; separate the boys and girls and sort by age.) You must complete the Summary Form and mail with the entry whether you use the disk entry or the non-computer entry form. A club contact person must be listed on the entry summary form. A \$5.00 surcharge per swimmer will be imposed on teams, with 5 or more swimmers, that have submitted written entries. This processing fee must be included with your entries. WARM-UP PERIOD: Warm-ups will be broken into two sessions beginning at 11:30 AM and 11:55 AM. The first 20 minutes of each session will be assigned warm-ups, in lanes by team. **No diving off blocks or the edge of the pool** during this time. The last five minutes of each session will be sprints with all starts beginning at the starting block end. Swimmers must swim one length and exit the pool at the opposite end, after all starts. Swimmers must be under the direct supervision of a currently registered coach. All unattached swimmers and swimmers without a coach must report to the Meet Director prior to warming up. USA Swimming and Middle Atlantic safety procedures will be enforced. Swimmers violating safety procedures will be removed from warm-up for the remainder of the warm-up session. Subsequent violations will cause the swimmer to be disqualified for the remainder of the meet.

DECK ENTRIES: Subject to space availability, deck entries will be accepted on the day of the meet, (prior to the start of each session, if applicable) at the cost of \$5.00 per event. Deck-entered swimmers will compete unofficially - times will count but will not score in the meet for awards. To enter, please see the Meet Director before or during warm-ups.

STARTS – This meet will be run using the whistle start, supplemented with verbal commands, and no recall false start rules.

RESULTS: Results will be posted on the DST website (delawareswimteam.com) and on the Middle Atlantic Website (www.maswim.org) Any team/parents wishing results may use the order form on the heat sheets. Orders will be taken at the Ribbon Writing Table. Cost: \$7.00.
