## GENERAL INFORMATION

**FACILITY:** The Suburban Swim Center is an 8 lane, 25 yard pool equipped with lane lines and starting blocks; the pool is 8 ft deep at starting end tapering to 5 feet deep at the far end. A separate warm-up/warm-down pool will be available throughout the meet. A Colorado timing system with one lane scoreboard display will be used. Refreshments will be available in the concession area. There is a separate spectator area and adjacent parking for 75 cars. There is additional parking close by but teams are encouraged to carpool.

**ENTRIES:** ALL EVENTS WILL BE TIMED FINALS. The meet is open to all swimmers registered with USA Swimming who meet the listed qualifying times and will be conducted according to current USA Swimming Rules. A swimmer shall be permitted to compete in **three (3) events per session, with a maximum of five (5) per day**. The entry fee is \$3.00 for each individual event entered. There will be no relays. Entries must be received **NO LATER THAN 5 PM MONDAY, OCTOBER 11, 2004!** Entries submitted after this date will be rejected. At the discretion of the Meet Director and Meet Referee, deck entries may be accepted. Any swimmer wishing to deck-enter an event must do so thirty (30) minutes before the start of that event. The fee for deck-entering an event is \$6.00 and the swimmer will be seeded in the slowest heats. All meet entries should be submitted on a disk using a HY-TEK compatible program (e.g., Commlink). A printed hard copy of the entries must accompany the disk. We encourage all clubs to enter on disk, regardless of the number of swimmers entered. If this is not possible, the official entry form must be used. If entering more than five (5) swimmers on this form, a processing fee of \$5.00 per swimmer must be included.

You can also e-mail your entries to [office@maswim.org](mailto:office@maswim.org) . Send check and the REQUIRED meet summary sheet to the above address. If you send entries via e-mail DO NOT ALSO SEND A DISK VIA SNAIL MAIL. Please waive the signature on all FedEx, UPS, Express, etc deliveries.

**MEET ENTRY LIMITATIONS:** The Meet Director reserves the right to make any changes that become necessary to ensure the meet complies with Middle Atlantic guidelines. Any teams/swimmers eliminated due to time or space constraints will be given a full refund.

**ACCORDING TO USA/MA RULES, ALL ENTRIES MUST BE MADE WITH THE SWIMMER'S BEST TIME IN AN EVENT:** A penalty of \$25 per event will be assessed on any swimmer who fails to swim the qualifying time in any event unless proof of time can be provided. Notice will be sent to each Club for those swimmers not swimming the Qualifying time, and the Club will be required to pay the penalties or provide proof of time. Enforcement of this rule will be done on a basis to be determined by the Senior Committee.

**EVENT SEEDING:** All events, except the 1000 and 1650 Freestyles, will be pre-seeded and will swim slow-to-fast. Times for swimmers entered with a long or short course meter time will be converted by Meet Manager and will be seeded as conforming times. Meter times should NOT be converted for entry to this meet.

The 1000 and 1650 Yard Freestyle events will be deck-seeded, and will swim fast-to-slow, alternating women and men. Competitors in the 1000 and 1650 Free must provide their own timers and counters.

**STARTING PROCEDURE:** This meet will be conducted using the 'No Recall' false start rule and the 'whistle command' starting procedure.

**COACHES INFORMATION:** The Meet Director or Meet Referee may call a Coaches meeting twenty (20) minutes before the start of the first session. Coaches are responsible for the good behavior of their swimmers and the avoidance of vandalism. Swimmers must not enter posted areas. Teams are responsible for maintaining cleanliness in their areas during and after the meet sessions. **Coaches must have and display their current USA coach's cards. No coach will be permitted on deck without this identification.**

## IMPORTANT SAFETY NOTICE

**WARM-UPS:** USA Swimming and Middle Atlantic Swimming rules for safety during warm-ups will be in effect at all times. This includes the use of the warm-up pool during the competition. Diving and backstroke starts will be prohibited in any part of the pools, except in sprint lanes when designated. Violators of these rules will be subject to removal from the remainder of the warm-up period.

A warm-up and warm-down pool will be available during the meet. USA-Swimming Safety Rules will apply in both pools at all times. Swimmers without a coach should report to the meet director before start of warm-up.

**AWARDS:** None

**SCORING:** The meet will not be scored.

**ADMISSION:** Each session admission will be \$3.00. Heat sheets will be posted as soon as available.

**RESULTS:** The results will be posted on the Middle Atlantic website ( [www.maswim.org](http://www.maswim.org) ). Entry disks will be returned with a results file added, upon request.

**VOLUNTEER WORKERS:** MIDDLE ATLANTIC CLUBS WILL BE RESPONSIBLE FOR PROVIDING VOLUNTEER WORKERS for this Meet: Each Middle Atlantic Club must submit the name and telephone number of a Contact Person with their entry form. The Senior Committee will contact those individuals after the entries are submitted to arrange for the necessary workers to run the meet. **No entries will be accepted without a designated contact for workers. Middle Atlantic Clubs are responsible for fulfilling their obligations.**

If you have any questions about officiating, please call Fred Killian at (302) 994-3389. **All officials on the deck must display their USA Swimming membership cards. No other people, except essential meet personnel, will be allowed on deck.**

**DIRECTIONS:** **FROM WEST(ROUTE 30):** Take the PA-100 exit towards EXTON/US-202/WEST CHESTER. Turn RIGHT onto POTTSTOWN PIKE, proceed for 0.56 miles. Take the US-202 S ramp and proceed for 3.98 miles. Take the PA-3 E exit towards NEWTOWN SQ. Merge onto W CHESTER PIKE/PA-3 E and proceed for 10 6.65 miles. Turn RIGHT onto S NEWTOWN STREET RD/PA-252, 1.06 miles. Turn LEFT onto GRADYVILLE RD. The Suburban Swim center will be the first building on your left.

**FROM THE WALT WHITMAN BRIDGE:** TAKE I-95 SOUTH TO I-476 NORTH. Take the US-1 exit- exit number 5- towards LIMA/SPRINGFIELD, 0.27 miles. Keep LEFT at the fork in the ramp, 0.02 miles. Keep LEFT at the fork in the ramp, 0.06 miles. Keep LEFT at the fork in the ramp, 0.12 miles. Keep RIGHT at the fork in the ramp, 0.28 miles. Merge onto US-1 S, 0.90 miles. Take the PA-252 exit towards MEDIA/NEWTOWN SQ., 0.22 miles. Keep RIGHT at the fork in the ramp. Merge onto N PROVIDENCE RD/PA-252. Stay straight for 2.5 miles. Turn RIGHT onto GRADYVILLE RD. THE SUBURBAN SWIM CENTER WILL BE THE FIRST BUILDING ON YOUR LEFT.

**FROM COMMODORE BARRY BRIDGE:** TAKE I-95 NORTH TO I-476 NORTH. Take the US-1 exit- exit number 5- towards LIMA/SPRINGFIELD, 0.27 miles. Keep LEFT at the fork in the ramp, 0.02 miles. Keep LEFT at the fork in the ramp, 0.06 miles. Keep LEFT at the fork in the ramp, 0.12 miles. Keep RIGHT at the fork in the ramp, 0.28 miles. Merge onto US-1 S, 0.90 miles. Take the PA-252 exit towards MEDIA/NEWTOWN SQ., 0.22 miles. Keep RIGHT at the fork in the ramp. Merge onto N PROVIDENCE RD/PA-252. Stay straight for 2.5 miles. Turn RIGHT onto GRADYVILLE RD. The Suburban Swim center will be the first building on your left.

**FROM NORTH (PLYMOUTH MEETING):** Take I-476 S. for 10.60 miles. Take the PA-3 exit- exit number 4- towards UPPER DARBY/BROOMALL for 0.21 miles. Keep RIGHT at the fork in the ramp. Merge onto W CHESTER PIKE/PA-3 W. for 3 miles. Turn LEFT onto PA-252./S NEWTOWN STREET RD for 1 mile. Turn LEFT onto GRADYVILLE RD. THE SUBURBAN SWIM CENTER WILL BE THE FIRST BUILDING ON YOUR LEFT.
